IMPLEMENTATION REVIEW (PIR)

1. In line with the goal of the K to 12 Basic Education Program, particularly on EPP, TLE, TVL, and SPTVE curriculum and program implementation status, assessment, best practices, and initiatives, the regional office through the Curriculum and Learning Management Division shall conduct a 2-day program implementation review with the Education Program Supervisor coordinating the abovementioned programs on December 1-2, 2022 at Balanghai Hotel and Convention Center, Butuan City.
3. The participants for this activity are the Division Education Program Supervisors coordinating the EPP, TLE, TVL, and SPTVE programs.
4. The objectives of this activity are to:
 - provide an update on the program's current status as well as an overview of PAPs, curriculum implementation, and assessment;
 - collect best practices for putting various PAPs into action; and
 - develop program action plans and target setting as ways forward in the implementation of PAPs.
5. Participants shall prepare their annual report in EPP, TLE, TVL, and SPTVE in a powerpoint presentation. They are also required to bring their laptop, an extension cord, and pocket WIFI if necessary.
6. Travel expenses and the per diem of participants are chargeable against local funds, while board and lodging are charged against HRTD OSEC 13-22-3758.



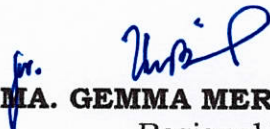
