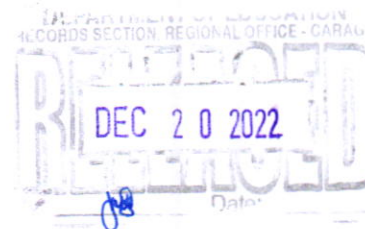

TRAINING-WRITESHOP ON THE DEVELOPMENT, QUALITY ASSURANCE,
AND PILOT TESTING OF REGIONAL ACHIEVEMENT TEST

1. The field is hereby informed of the conduct of face-to-face "Training-Writeshop on the Development, Quality Assurance, and Pilot Testing of Regional Achievement Test" on January 25-29, 2023 (venue to be announced).
2. The training aims to:
 - infer the appropriate Bloom's cognitive levels and 21st century skills (information literacy, critical thinking, and problem solving) of the Most Essential Learning Competencies;
 - generate a sample TOS based on the Revised Bloom's Taxonomy
 - assess the appropriateness of the given test questions based on the characteristics of a good multiple choice type of test for literacy and numeracy, and PISA design formats;
 - generate a sample multiple choice type of test based on the TOS (items tagged according to the Bloom's Taxonomy, and 21st century skills);
 - explain the process of determining the validity and reliability of test items during/after a pilot testing;
 - perform calculations involving validity and reliability of test questions;
 - explain the variables involved in the analysis of learning outcomes as prescribed by the key performance indicators under Quality;
 - perform calculations to generate key performance indicators for Quality (MPS, proficiency levels, and least-learned competencies) ;and
 - discuss context-based test administration, management, and security protocols for census and sampled testing.
3. The participants of this activity are the Education Program Supervisors of the eight learning areas (English, Filipino, Math, Science, Aral. Pan., MAPEH, EPP/TLE/TVL/TVE, and EsP), MTBMLE Coordinators, ELLN Coordinators, and Kindergarten Coordinators from both the Regional Office, and the Schools Division Offices.
4. Each SDO shall send 11 participants. If in case an EPS or Coordinator handles two or more learning areas and/or programs indicated in item 3 of this Memorandum, the SDO shall select another participant to take charge the learning area or program (preferably EPS, PSDS, or School Head).
5. SDOs are required to accomplish the "Division List of Participants" indicated in Enclosure A. It must be sent to kevinhope.salvana@deped.gov.ph on or before January 6, 2023.
