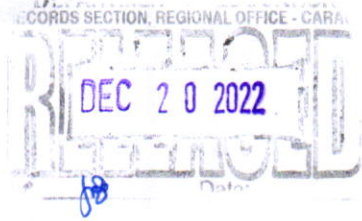

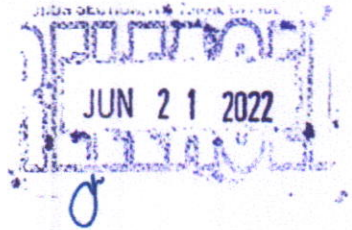

COUNTERPARTS IN THE SDOs**

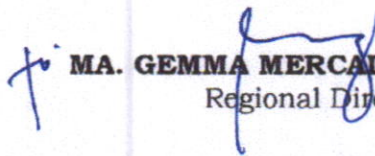
