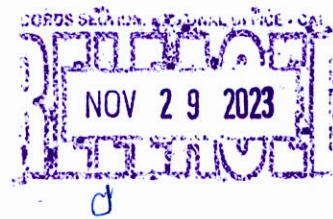

**PROFILING OF TECHNICAL OFFICIALS FOR THE 2024 REGIONAL SPORTS
COMPETITION**

1. In preparation for the 2024 Regional Sports Competition, DepEd Caraga would be profiling potential technical officials per sports event, and shall be recommending technical officials to participate in the national accreditation in December 2023.
2. Schools Division Offices (SDOs) through the Division Sports Officers (DSOs) shall recommend three (3) competent technical officials (either teacher, school head or any non-teaching personnel) per sports event based on the following criteria:

Criteria	Details
Age (preferably 52 years old and below)	Preferably 52 years old and below to ensure that after receiving the national accreditation, services of the accredited TOs would be maximized for 3 years.
Must have served as TO in the lower meets	Should have at least served as Technical Official in lower meets (Division/City/Provincial Meet or Regional Meet).
Physically Fit	Recommended TOs should have at least secured a medical certificate (private/public) that is still valid until January 2024, meaning issued in November 2023.
Possesses knowledge and skills of the event	Should attach certificates to vouch competence. These certificates are, but not limited to the following: a. Awards/Recognitions (as coach on the event to officiate) b. Trainings (relevant to the event to officiate, and preferably at least one certificate from Division, Region, National and International levels) c. Previous accreditations (relevant to the event to officiate) d. Others (relevant to the event to officiate)
