**SUBMISSION OF REGIONAL MONITORING EVALUATION AND ADJUSTMENT
(RMEA) AND PROGRAM IMPLEMENTATION REVIEW AND PLAN
ADJUSTMENT (PIRPA) REPORTS FOR 3RD QUARTER CY 2024**

1. With the intent to strengthen the Regional Monitoring, Evaluation and Adjustment (RMEA) and Program Implementation Review and Plan Adjustment (PIRPA) in the Regional Office and Schools Division Offices as a strategic mechanism to review, discuss, and utilize the performance inputs in providing technical assistance and support, RO Functional Divisions and Schools Division Offices are directed to submit the 3rd Quarter RMEA-PIRPA Report on **December 6, 2024**.

 - ii. PPAs with other Budgetary Allocations (SEF, PSF, etc.)
 - c. Implementation Status of PPAs with no Budgetary Allocations.
 - d. Catch- Up Plan
3. The RO Functional Divisions and Schools Division Offices are hereby directed to use the RMEA and PIRPA templates which can be accessed and downloaded at **<https://bit.ly/R13RMEA>**.
4. Duly signed reports shall be uploaded on the same link.
5. The presentation of the reports stipulated in RM 0181, s. 2024 is cancelled. However, consolidated reports of RO FDs and SDOs as well as actionable implications of the analyzed reports shall be presented by QAD to the RFTAT Meeting and the management committee meeting.
