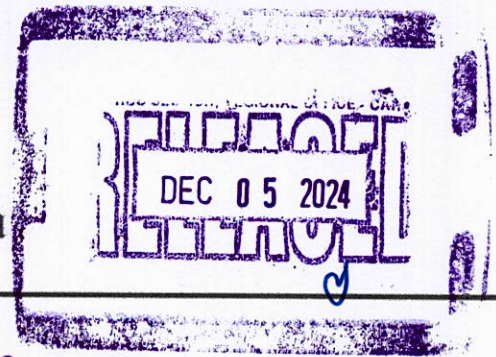

2024 GENDER ANALYSIS OF DEPED GAD PROGRAM IMPLEMENTATION

- As part of the Gender and Development (GAD) Program Implementation, Division GAD coordinators, along with the Regional GFPS and/or their alternate representatives, are required to convene and prepare the consolidated 2024 DepEd Caraga GAD Accomplishment Report and conduct a gender analysis using Gender Mainstreaming Evaluation Framework (GMEF).
- This activity is scheduled on December 10, 2024, at Almont Inland City Hotel, Butuan City. Participants are expected to arrive on December 9, 2024 as day 0 and the activity shall start no later than 8:00 a.m. to fully utilize the allocated 8-hour session.
- Only one-night accommodation, 3 meals and 2 snacks will be provided to participants. Other travel expenses, including lodging, dinner, breakfast, and transportation, will be charged against local GAD funds and must comply with standard accounting and auditing regulations.
