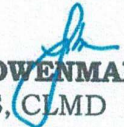

The total amount of **₱237,266.00** shall be charged against **Sub-Allotment Release Order (SARO) No. OSEC-13-24-1005**.

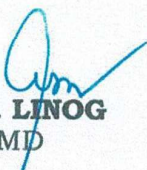
