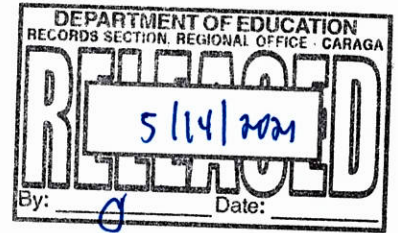

MONITORING OF OPLAN KALUSUGAN SA DEPARMENT OF
EDUCATION (OK SA DEPED) PROJECTS,
PROGRAMS AND ACTIVITIES

1. Pursuant to DepEd Order No. 028 s, 2019 on the Policy and Guidelines on Oplan Kalusugan sa Department of Education (OK sa DepEd), the Regional TWG is expected to monitor the activities of the SDOs, the progress of implementation, as well as issues and concerns on the preparatory activities and actual program implementation.
2. In view of the foregoing, the Regional Health Team shall visit your respective divisions and upon arrival will conduct a focused group discussion on the implementation of OK sa DepEd PPAs as indicated in your submitted actions plans for 2021.
