**ANNOUNCEMENT OF SCHOOLS WITH APPROVED PERMIT TO OPERATE

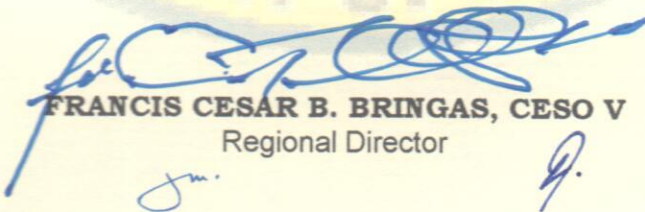
