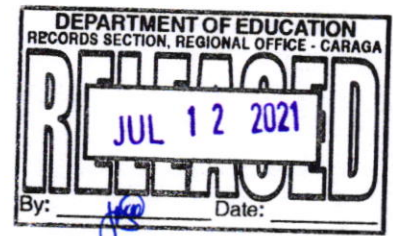

WEBINAR ON ALTERNATIVE DISPUTE RESOLUTION

1. To equip our grievance committee members with knowledge on settling grievances at the lowest possible level in the Department, the Department of Education Caraga Region through the Human Resource Development Division shall conduct a Webinar on Alternative Dispute Resolution on August 10-13, 2021, via Zoom.

 - c. apply the value-laden approach in dealing with disputes inside the office.
