This memorandum provides guidance on the allocation for FY 2021 Organizational and Professional Development for Non-Teaching Personnel (OPDNTP) including the direct release for Program Support Fund (PSF) to the Regions and Schools Division Offices.

Based on FY 2021 GAA, the funding source name of Organizational and Professional Development for Non-School-based Personnel (OPDNSP) has been changed to Organizational and Professional Development for Non-Teaching Personnel (OPDNTP) amounting to Php 107,425,000.00 and Php 3,500,000.00* from FY 2020 continuing fund.

In view of this, please be guided on the breakdowns of the FY 2021 OPDNTP budget (*Annex B*) and Programs Support Fund (*Annex C*) directly released to the Regional Offices under For Comprehensive Release (FCR). The allocation of the PSF was computed equitably based on initial physical targets identified per region. The ROs may download the equitable amount of this fund to their SDOs if necessary.

The PSF shall be utilized for the **Learning & Development interventions for non-teaching personnel** from all DepEd offices and public schools, using alternative learning delivery modalities during the period of State of Public Health Emergency, pursuant to the guidelines, mechanisms, and procedures stated in DepEd Order No. 40, s. 2020 re. "Implementation of Learning and Development for Non-Teaching Personnel in the Department of Education in view of the COVID-19 Pandemic".

Considering IATF rules and the varied situations across ROs and SDOs, the said offices may set targets on their respective L&D plan, provided it is governed by DO 40, s. 2020 and other existing rules and regulations on the conduct of programs and activities.

In addition, **plans and accomplishments on the utilization of the FY 2021 OPDNTF PSF** must be updated by the Program Focal of Offices/Divisions in the Central Office and HRD Focal in the Regional Offices, as part of the monitoring requirement specified in the DO 40, s. 2020. The links for the online monitoring tool in Google Sheets format are provided in **Annex A**.
