OF THE DEVELOPMENT ACADEMY OF THE PHILIPPINES (DAP)**

1. The Development Academy of the Philippines (DAP) announces its offering of the Public Management Development Program (PMDP) for Middle Managers Class (MMC) Batch 27.
2. The program is designed to prepare middle managers for career executive positions in the government. A Master in Development Management degree will be conferred upon fulfillment of the academic requirements of the PMDP under a ladderized scheme.
3. Classes will begin on August 02 under flexible learning mode. Sessions are conducted from Monday to Friday, 8:00 Am to 5:00 PM. It will run continuously for 3 weeks per month. The duration of the entire program is one (1) year.

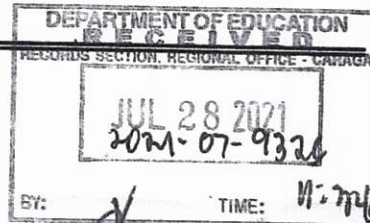

The Development Academy of the Philippines (DAP) will have its Public Management Development Program (PMDP) Middle Managers Class (MMC) Batch 27 which will open on 2 August 2021 under a flexible learning mode.

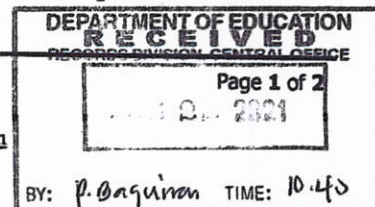
The MMC is designed for Division Chiefs (SG 24) or those in equivalent positions who are in succession for 3rd level posts. Designated OIC-Division Chiefs for at least a year are also eligible for nomination. The MMC is also open to high-performing and high potential individuals with SG 23 to SG 18. All nominees must not be older than 50 years old.

The completion of the PMDP will prepare the scholars for career executive positions in the government. Upon fulfillment of the academic requirements of the said program, scholars will also earn a Master in Development Management degree under a ladderized scheme.

The PMDP virtual classes are scheduled from Monday to Friday, 8:00 AM to 5:00 PM with synchronous and asynchronous sessions continuously for three weeks per month.

MIDDLE MANAGERS CLASS (MMC)

QUALIFICATIONS

- Incumbent of a permanent position with Salary Grade 18 to 24 (*Current OICs of SG 18-24 positions for at least a year are also eligible*)
- Division Chief or those in equivalent positions who are in succession for 3rd level posts
- Aged 50 years old and below
- Filipino citizen
- At least a bachelor's degree holder
- Nominated by the Head of the Agency (*Nominations made by the Regional Directors and other officers vested with the authority to nominate must be certified/confirmed by the Central Office*)
- From a national line agency or its attached agencies, constitutional offices, legislative and executive offices, and government-owned and controlled corporations, and SUCs
- Has Very Satisfactory or Outstanding performance rating for the past two years
- Must be in government service for at least two (2) years
- Has no pending administrative and/or criminal case
- Did not go on habitual leave (max of 2 months/year, excluding maternity leave)
- Must be in good health (no debilitating, chronic illnesses or serious health condition)
- Must have excellent communication skills (both oral and written)
- Willing to sign a Tripartite Memorandum of Agreement with DAP and his/her agency
- Willing to render at least a year of service in his/her agency after completion of the Program through a Service Contract
