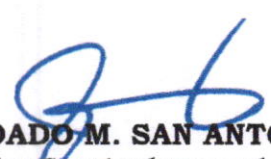
**ONLINE WORKSHOP ON THE FINALIZATION OF BALIK KASAYSAYAN
POLICY GUIDELINES AND SAMPLE LEARNING MATERIALS**

1. The Department of Education is conscientiously preparing all essential requirements to ensure its mandate is accomplished in continuously providing quality, accessible, relevant, liberating learning opportunities for all Filipino learners.
2. For this reason, the Bureau of Learning Delivery-Teaching and Learning Division (BLD-TLD) will conduct an **Online Workshop on the Finalization of the Balik Kasaysayan Policy Guidelines and Sample Learning Materials** on December 10-19, 2020. The opening program will be on December 10, 2020 at 9:00 AM. The program of activities is in the attached Annex A.

6. Miscellaneous expenses of BLD-TLD specialists including training/workshop expenses shall be charged to the activity funds, subject to the usual accounting and auditing rules and regulations. Training/workshop expenses of participants shall be downloaded to the concerned Regions from the 2020 BEC Funds. Regional offices are encouraged to download the funds to the respective divisions. In the event that the downloaded funds are not sufficient to cover the actual training/workshop expenses of the participants, the ROs/SDOs shall allow the participants to reimburse the remaining balance from the Region/Division/School MOOE, subject to the usual accounting and auditing rules and regulations.
