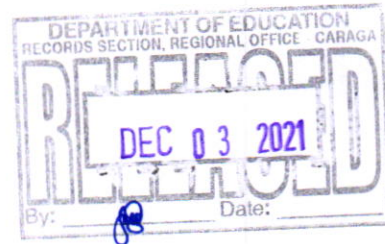

Date : 01 December 2021

As an off shoot of the first BCD Learning Session held in November, this Department, through the Bureau of Curriculum Development, will once again hold BCD Learning Session, second in the series, a panel discussion on EDUCATION BEYOND THE NEW NORMAL. Similar to the first BCD Learning session, this event will likewise draw important learning, but this time from the private sector, from how challenges were confronted to how learning continuity was managed in spite of the limitations in adherence to the safety measures and health protocols imposed by the government.

After initially learning from the perspective of leaders from DepEd, BCD Learning Session II will shift the focus to the private sector, as the Department continuously draw inputs from the different stakeholders who also face the same issues as the public schools. The panel discussion will surely bring forth substantial feedback and in-depth understanding as both public and private institutions grapple with the inevitable change. The discussion aims to:

- a. learn from the representatives of the private sector the specific challenges they faced as a result of the health crisis;
- b. share their best practices on how they confronted the issues at hand;
- c. discuss possible innovations which DepEd may consider in implementing the necessary changes as a result of the new normal; and
- d. gain insights from the responses of the panelists on how they managed (or still managing) the challenges.
