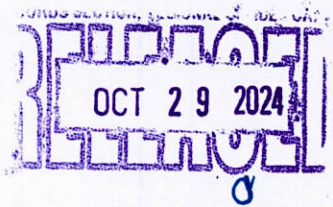

This has reference to the Development of Positive Discipline (Pos-Di) Learning Action Cell (LAC) Session Guides by the Learner Rights and Protection Office (LRPO) and the Bureau of Learning Delivery-Teaching and Learning Division (BLD-TLD).

Pursuant to the DepEd Order No. 40, s. 2012 or the "DepEd Child Protection Policy", which prohibits the use of corporal punishment and instead uses positive and non-violent approach to discipline¹, LRPO together with the BLD-TLD crafted the session guides to strengthen the use of positive discipline as a behavioral management technique in schools. The LAC Session Guides have undergone consultation and review, it has integrated all learner protection policies, including theories on the importance of discipline in schools.

Accordingly, the LRPO will be conducting a National Orientation Workshop on the LAC Session Guides, aimed to familiarize our school personnel on the use of positive discipline and changing generational belief on corporal punishment. The Orientation shall serve as a prelude before the actual National Training of Trainers.

In line therewith, may we request the regional heads to identify the respective representatives from their region who will serve as participants for the national orientation, and will be expected to serve as discussants in cascading the lessons to their respective regions, divisions, districts, and schools:

1. Regional and/or Division Learner Rights and Protection (LRP) Focal Person;
2. Representatives from the Curriculum Implementation Division (CID);

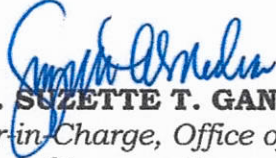
