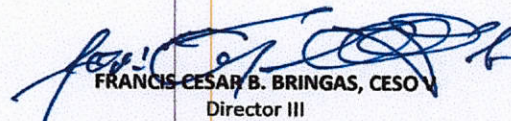

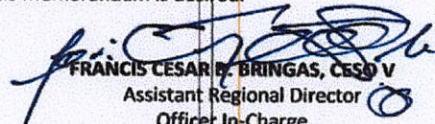

1. Pursuant to DepEd Order No. 16, s. 2019 on the amendment of DepED Order No. 7, s. 1999 (Policies on Selection/Appointment and Transfer/Re-assignment of DECS Regional Officials) provides that "there shall be a simultaneous transfer/reassignment of RDs, ARDs, SDS, ASDs once every three (3) years.
2. With this, the Regional Human Resource Merit Promotion and Selection Board (HRMPSB) will conduct a Profiling of Candidates for the Third Level Position to come up with a pool of Career Executive Service Position Qualifiers.
3. All Career Executive Service Written Examination (CESWE) Passers (see attached list) are required to submit their updated PDS in folder to HRMO and HRMPSB Secretariat Mrs. Sheryl R. Puyo on or before December 12, 2019. The updating includes among others Certificate of Rating or Certifications of any of the 4 stages of CES Eligibility Process. They are also requested to attend a half day interfacing with the HRMPSB and the Regional Director on December 17, 2019 from 8:00 to 12:00 Noon at RELC 2.
4. Incumbent ASDs are requested to be at the RELC 2 on December 17, 2019 from 1:00 to 5:00 PM bringing with them their LOI for 3 Division preferences for their proposed transfer/reassignment per DepED Order No. 16, s. 2019.
